RESOLUTION RE: SALE OF REAL ESTATE DESCRIBED AS 102 CREEK ROAD CALAMUS, IOWA 52729

WHEREAS, the City of Calamus, Iowa, currently owns 102 CREEK ROAD CALAMUS IOWA 52729;

WHEREAS, Iowa Code §364.7 provides that a City may dispose of an interest in real property by sale, gift or otherwise, after a public hearing thereon.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CALAMUS, IOWA, AS FOLLOWS:

That the real estate described as City property being 102 Creek Road Calamus Iowa 52729, shall be listed for sale by Curtis Dosland, the real estate agent selected by the City, with a minimum list price of \$180,000.00.

That upon receipt of an offer to purchase the property from a Buyer that the City wishes to accept, the Mayor and City Clerk are authorized to execute the purchase agreement, and execute all additional necessary documents including a Warranty Deed, to close on the sale of the property to the Buyer thereafter.
