Calamus City Council Proceedings June 1, 2015

Mayor Steines called the regular meeting of the Calamus City Council to order at 6:00 p.m. with council members Kalfas, Smith, Boedeker, Haack and Dieckmann present. Also present were city employees Laurie Ganzer and Duane Levien.

A motion to approve the street closing on July 11th for the **Calamus Fun Days** was made by Kalfas with a second by Dieckmann. All ayes.

Employee Contracts – Duane Levien - 2% increase, permanent part time - \$12.50 per hour, seasonal part time - \$10.00 per hour, snow removal - \$12.00 per hour, Laurie Ganzer - \$200.00 per month increase. The **Clinton County Sheriff's Office** spent 65.58 hours in the city of Calamus from April 26, 2015 through May 25, 2015 while on patrol they handled 1 incident and answered 2 calls.

Reports – Kalfas reported that the owner of 100 Main Street is interested in selling the property to the City for \$3,500.00, the council informed Kalfas to tell the owner they are not interested in the property.

Several spot in the streets have holes of undetermined depth and soft spots. Dieckmann will discuss this with Levien.
